



# WILL COUNTY CONSTRUCTION / DEMOLITION CONTRACTOR REPORTING FORM

The Will County Waste Hauler Reporting Ordinance requires your company to submit a written report to the Will County Land Use Department, Waste Services Division, every six months. You must report the amount of landscape waste hauled from Will County jobsites (in both municipalities and townships) during the previous six-month period. Please report your best estimates in either cubic yards or tons. **This report is due 30 days after each six-month reporting period ends.**
